MINUTES OF ANNUAL BUSINESS MEETING

LA CROSSE CENTER, LA CROSSE, WISCONSIN

JUNE 8, 2012

The meeting was called to order at 11:43 a.m. by the President, District Governor Chuck Hansen.

Forty-one member clubs were present, constituting a quorum. A listing of delegates in attendance is attached and is a part of these minutes.

Chuck Hansen, District Governor, summarizes the accomplishments in the Rotary Year 2011-2012:

- Rotary District 6250 Foundation. We have a district foundation that can support club projects and youth exchange.
- **Membership** achievements and new clubs creations in 2011-12.
- The District Leadership Academy has been organized and is ready for 2012-13. This committee will conduct training for our members on many leadership topics such as public speaking, conduction meetings, etc...
- **Future Vision Taskforce** for 2012-13. Dean Ryerson will chair this committee along with other district leadership. They will work with a sister district who is already a Future Vision District. This will help us get ahead of the curve. Change is coming and we need to be prepared for the change.
- Social Media Committee has been working on helping clubs establish themselves on Facebook, LinkedIn, etc... Chuck Hansen also says the website has had some improvements and it will continue to improve.
- **InterACT** has been expanding in our district. We are excited about InterACT and we want to grow it in more areas.
- Rotary Youth Exchange program. Chuck Hansen encourages clubs to participate in this great program.
- Growth in the **RYLA** program. RYLA attendees grew from 25 to 80 students in 2012. The event now takes place in Wisconsin Dells.
- **Group Study Exchange (GSE)** went to Australia this year. Chuck discusses the project the two districts are doing in a developing country. Thailand slums needs fire equipment. The GSE team from D6250 and D9640 are raising money to donate new equipment to 14 slum communities in Thailand.
- Two **Friendship Exchanges** took place in 2011-12: 1) Brazil and 2) India.
- District 6250 had **Ambassadorial Scholarships** both inbound and outbound. Two students from Japan are here. Our outbound student, Jessica Havens, is leaving this summer for India.

Minutes of Previous Meeting

The minutes of the annual business meeting of May 6, 2011, were not read because they had previously been distributed. One amendment was made to the minutes. In 2011 we nominated Dean Dickinson to the Zone *Nominating* Committee, but the minutes read Zone Committee.

A motion to approve the *amended minutes from the business meeting of May 6, 2011* was made by Rob Stroud and seconded by Dick Spencer. All approved, none opposed. Motion passed.

Treasurer's Report

District Treasurer, Dick Spencer, presented and discussed interim financial statements from July 1, 2011, to May 31, 2012. He anticipates District 6250 unrestricted cash balance reserve to be approximately 30% of annual expenses at year end June 30, 2012.

2012-13 District Budget

District Governor-Elect Rob Stroud presented the 2012-2013 Operating Budget. Rob discusses the use of the reserves to help supplement the budget. Rob says we've done this for too long and now the reserves are low. Our dues in District 6250 are lower compared other districts. Club dues are the largest income into the budget. Membership is a key to keeping a balanced budget. We have fixed costs that we need to cover every year. The more members we have the more effective we will be.

We are recommending a \$5.00 increase to annual member district dues. This will help stabilize the budget for the next few years. This will bring the annual district dues per member to \$40.00 per member per year. Discussion about the budget. A member asked if we could have a breakdown of the budget compared to last year to see what the changes are from year to year. Rob Stroud says that is available and can be distributed (may be available on the website).

A motion to approve the *2012-13 District Operating Budget* was made by Joe Ruskey and seconded by Jerry Cleveland. All approved, none opposed. Motion passed.

A motion to approve the \$5.00 increase to annual membership dues was made by Dean Dickinson and seconded by Dave Warren. All approved, none opposed. Motion passed.

Board Member Elections

Dean Dickinson, PDG, of the District Nominating Committee presents two *at-large members to the District 6250 Board of Directors*. The nominating committee nominates Jim Raymond, Rotary Club of Edgerton, and Deb Fox-Schroeder, Rotary Club of Sun Prairie to the District Board of Directors. No other nominations were presented. Rob Stroud moves to close the nominations.

Motion to approve at-large members Jim Raymond and Deb Fox-Schroeder to the District Board of Directors was made by Dean Dickinson and seconded by Dave Warren. All approved, none opposed. Motion passed.

Dean Dickinson, PDG, of the District Nominating Committee presents two *at-large members to the District 6250 Nominating Committee*. The primary function of this committee is to select the District Governor Nominee each year. The two at-large members presented are Donella Magadance, Rotary Club of Eau Claire Morning, and Janie Spencer, Rotary Club of La Crosse Valley View. No other nominations were presented. Rob Stroud moves to close the nominations. Motion to approve at-large members Donella Magadance and Janie Spencer to the District 6250 Nominating Committee was made by Dick Spencer and seconded by Toni Pabon. All approved, none opposed. Motion passed.

Dean Dickinson, PDG, of the District Nominating Committee presents the *District Governor Nominee 2014-15*. The nominating committee nominates Dave Warren, Rotary Club of Janesville Noon, as District Governor Nominee 2014-15. Rob Stroud moves to close the nominations. Motion to approve Dave Warren as District Governor Nominee 2014-15 was made by Dean Dickinson and second by Jerry Cleveland. All approved, none opposed. Motion passed.

The meeting was adjourned at 11:59 a.m.
